# **Project Summary**

### What:

- support the implementation of the energy labelling of heating appliances
- boosting its impact on solar thermal products using the "package label"

### Whom:

- those managing and issuing the label: manufacturers / distributors / installers
- end consumers

## Why:

- lack of information about package label is a market barrier
- package label is a tool for differentiation and uptake of RES in H&C

- "Label Pack A+ National Stakeholders Platform"
- Monitoring implementation
- European sinergies





# **Expected impacts**

- Better implementation in six important solar thermal markets (80% market)
- ST sector making best use of tool
- Consumers better informed and empowered
- Recommendations and feedbacks for EC and MS
- Pave the way for an easy replication of the initiative in other markets

- ✓ Provide tailor-made information for end consumers












# **Energy Labelling Directive**



# Rescaling

- Fixed deadlines are established for the first rescaling of all labelled products
- Once all A+ labels have disappeared from the market, further rescaling will be triggered by a surplus in the top classes, namely 30 % in class A or 50% in class A+B.
- At the time of rescaling the top class is to be left empty (top two for lots with fast technological development), aiming for a ten-year validity period of the label.
- Space and water heaters will be implemented later: between 2026 and 2030!

# **Product database**

- Set up from January 2019
- Restricted part:
  - aiming at enabling market surveillance authorities of member states to enforce labelling requirements
  - make sure that efficiency calculations correspond to those declared
- Public database
  - focus on user friendliness and practical purposes
- Consultation
  - Discussion with stakeholders ongoing
  - Studies and internal COM work

# **Review Study**



### Assessment of:

- The appropriateness of setting ecodesign requirements for greenhouse gas emissions related to refrigerants, carbon monoxide and hydrocarbons;
- The appropriateness of setting stricter ecodesign requirements for emissions of nitrogen oxides;
- The appropriateness of setting requirements for products working on gaseous and liquid fuels from biomass;
- The validity of the primary energy factor (PEF);
- The appropriateness of 3rd party certification;
- Significant changes in market shares of various types of appliances;
- The appropriateness of the package labels and fiches.

# Conversion coefficient value




- Primary Energy Factor (PEF), applied in:
  - Energy Efficiency
     Directive
  - Energy Performance of Buildings Directive
  - Though Member States can define their own values
- PEF = CC in Lot 1 & Lot 2

- Currently: 2.5

- Proposal: 2.0

- Open question:
  - How will the new PEF value be applied in the Lot1 & Lot 2 review?
    - With or without update on the thresholds



# Third party certification



- Issues:
  - Poor market surveillance
    - Water and space heaters
  - Need to ensure fair competition
    - Industry proposing mechanisms to ensure fairness in the market
  - Additional procedures/requirements
    - New certification requirements could imply additional costs/burden to manufacturers
    - Clarify if existing certification (ex: Solar Keymark) would be compatible



# Package fiches and labels



- What can be covered under "appropriateness"
  - Procedures
  - Calculation
  - Components
  - Information supplied
  - Availability of information
  - Implementation in the market
  - Market surveillance procedures
  - Withdrawal of the package label







# Interaction between LPA+ and review Lot1 & Lot 2

- Inputs from the project are likely to fit into the first stage of the review process
- Questions are not only regarding improvements on package label —> also on the continuation of the package label
- Important to understand scenarios:
  - Impact of having improved package label or no-package label
    - For market, consumers, manufacturers of different products
  - Requirements connected to each scenario: what actions to take to activate scenario


# Surveys

- Assessment of the implementation of package label
  - Clear problems with implementation in different countries
  - Data needed: two reference countries: Germany and Portugal
  - Add also information on the implementation of the product label
  - Germany
    - BSW survey: Private sector (installers, manufacturers); public entities (local, federal), NGOs (Industry Association/chamber; Consumer protection): 81 valid responses out of 108
    - Co2-online survey: 132 valid responses
  - Portugal
    - DECO: Online questionnaire to consumers: 210 valid responses
    - DECO: Inspection of 50 stores and 13 online shops


